During August, ERE Board held 3 meetings, which resulted in 14 decisions, among which:

Licensing of companies:

- 1.a."FAETHON" company in electricity production activity from the photovoltaic plant with an installed capacity of 93 MW, located in the Gjirokastër District, for a 25-year term, starting this term from 14.02.2027 and on the condition that the company reports at ERE every 3 months, regarding the progress of the start of works for the construction of the photovoltaic park and to document their start no later than 04.10.2025, which is also the deadline for the validity of the Environmental Declaration.
- 2.b."BMG ENERGY SAL" company in electricity production activity from the photovoltaic plant, with a production capacity of 2 MW, located in the Fier District for a term of 30 years, starting this term from 31.03.2025, provided that the company submits at ERE the new Preliminary EIA by 23.10.2024.
- 3.c."ACHELO" company, in electricity production from Kotorri HPP, with an installed capacity of 1.9MW, for a term of 30 years, starting from 04.08.2025, provided that the company submits at ERE the renewed permit of use of the water source within 16.11.2027.
- 4.d."SUN'S MIRACLE" company in electricity production activity from the photovoltaic plant with an installed capacity of 2MW, in Fier District, for a 30-year term starting from 15.09.2024.
- 5.e."Nova Prospect" company in electricity production activity from the photovoltaic plant with an installed capacity of 2 MW, located in Himarë Municipality, Vlorë District, for a 25-year term, starting from 30.08.2024 with the condition that the company submits at ERE the position of the Ministry of Infrastructure and Energy and/or the amendment of the signed contract, for the notification made by it on the change of the investment value of the project.

Opening the procedures to license the companies:

- POWER" **SOLAR** "MAGNA company in electricity production activity from the photovoltaic plant with an installed capacity of 2 MW, in Fier District. Approving the request of "KOKA & ERGI ENERGY STAVEC" company for increasing the installed capacity of "STAVEC" HPP " from 6,520 MW to 8,44 MW and the opening of the procedure for the modification of the license of the latter in the electricity production activity "Stavec" HPP, issued with ERE Board Decision no. 176, dated 04.11.2020.
- "HPG ENERGY" company in electricity production activity from the photovoltaic plant with an installed capacity of 2MW and auxiliary works, located in Fier Municipality.

Renewing the license of the companies

- "NOA ENERGY TRADE" company in electricity trading activity, issued with ERE Board decision no.07, dated 02.02.2015, renewed with ERE Board decision no.222, dated 20.12.2019, for a 5-year term starting from 04.02.2025.
- "Universal Service Supplier" company in electricity supply activity, issued with ERE Board decision no.97, dated 27.10.2014, renewed with decision no.164, dated 04.11.2019, for a 5-year term starting from 22.12.2024.

Decisions regarding the extension of term of the decision, fulfillment of predetermined conditions and incoming requests from licensed subjects:

- The extension to 30 (thirty) days of the term of ERE Board decision for the request of "BMG ENERGY SAL" company for license in electricity production activity.
- Repeal of points 2 and 3 of ERE Board decision no. 135, dated 09.07.2024
 "On licensing "5GX ENERGY" company in electricity production activity, as a result of fulfilling the predetermined conditions.
- The acceptance of the request of "KOKA & ERGI ENERGY STAVEC" company for the increase of the installed capacity of "STAVEC" HPP from 6,520 MW to 8,44 MW and the opening of the procedure for the modification of the latter's license in electricity production activity from "Stavec" HPP, issued with ERE Board decision no. 176, dated 04.11.2020.

Hearing Sessions

Part of ERE activity have been 3 hearing sessions held for resolving complaints and obtaining the position of the parties, as well as with licensed subjects, in order to clarify ambiguities and to result in a more complete decision-making.

ERE is responsible for the development of fee and price methodologies for activities regulated in accordance with the legislation in force and based on its analysis proposes improvements to existing methodologies.

Regarding this area of responsibility, during August, decisions were made on:

- 1. Approval of the sale price of electricity supplied by the Supplier of Last Resort for July 2024 of about 19.79 ALL/kWh for customers connected at the 35 kV voltage level.
- 2. Some amendments in ERE Board decision no. 287/2023 and no. 102/2024, as follows:
- The amendment of point 1 of ERE Board decision no. 287, dated 09.10.2023, amended with ERE board decision no. 50, dated 02.04.2024, on the approval of the "ALPEX Fee Schedule" which shall be applicable to the Nominated Electricity Market Operator (NEMO), until 31.12.2024. (Table attached).

The visit to Katuni wind farm, Croatia

The visit to Katuni wind farm, Croatia, part of the agenda for the decarbonization of the power sector in the Western Balkans, was developed as a collaboration between the GIZ organization's representatives in the Balkans, among which GIZ Albania.
