During May 2025, ERE Board organized two decision-making meetings, during which 17 decisions were reviewed and approved, aimed at the development and regulation of the energy

New Licenses

On 12 May 2025, "NAD Investment" company was licensed by the Energy Regulatory Authority (ERE) on electricity supply and trading activity for a 5-year period. This license enables the company to officially operate in the electricity market of Albania, contributing to the increase in the number of participants eligible to engage in energy trading and supply activities.

Procedures Initiated During May

During May, the Energy Regulatory Authority (ERE) initiated procedures for licensing "SunPro" company for the development of a wind power plant with an installed capacity of 3 MW in Vlora Region. This capacity shall contribute to the supply of clean energy based on renewable and sustainable sources.

The project foresees the installation of wind turbines using modern technology, adapted to the climatic conditions and average wind speed in Vlora region. The licensing procedure includes the review of technical, environmental, and financial documentation, and the verification of compliance with current legislation. The ongoing process must be completed within 90 calendar days from the date of the opening of the procedure.

This project represents an important step toward increasing investments in the renewable energy sector in Albania, supporting national objectives for energy source diversification.

Authorizations for Financial Guarantees

The Board approved the requests of several companies for placing quotas or assets as guarantees (mortgage) to financial institutions, to support investments or commercial activities. Authorizations were approved for:

- "5GX ENERGY" company
- "DELIU 3D" company
- "G.S.K" company
- "GREENNAT PARK SOLAR BALLSH" company "INFO-TELECOM" company

Additionally, the procedure for reviewing asset transfer authorization requests was initiated for the companies:

- "HYDROPOWER" company
- "DIMAX ALBANIA" company
- "C.E.P." company

Other Decisions

The conditions of decision no. 85/2025 for "ALBESP TRADING & CONSULTING" company were repealed, related to changes in the ownership company's structure.

On their meeting dated 12 May, ERE Board approved the electricity sale price for April 2025 by the Supplier of Last Resort for customers connected at 35 kV level, at about 11.51 ALL/kWh.

Regulatory payments for 2025 were also approved for all licensees in the power and natural gas sectors.

Public Hearing Sessions with the Interested Parties

During May, ERE organized 11 hearing sessions with customers and licensed subjects. The issues addressed included:

Resolution of disputes between customers and operators (FSHU, DSO)

Implementation of the 15-minute time interval in the balancing

Review of the compliance report by DSO

Progress of complaints and the measures taken by the respective operators
