ERE Board Decisions during July

During July 2025, ERE Board held 5 decision-taking meetings, where are reviewed and approved 40 Decisions in the support of developing and regulating the electricity market.

New Licensing

electricity supply and trading activity, for a 5-year period for each activity; "GRABOVA HYDROPOWER" company is licensed in electricity production activity, from "Grabova" HPP, with installed capacity 14.9 MW, located in the catchment area of the Grabova stream, branch of Devoll River, in Elbasan, for a 30-year period. According to the conditions of the licensing decision this company shall commence operation for electricity production within date 15.05.2027; "EZ-5 ENERGY" company is licensed in electricity production activity from the photovoltaic plant with installed capacity 30MW for a 30-year period, in Fier. This plant is planned to initiate operation within date 31.12.2025.

There are approved the amendments on Decisions no. 258, dated 21.12.2021, "On licensing "YILDIRIM ENERGY EUROPE ALBANIA" company in electricity supply activity", as amended, and Decision no. 199, dated 03.08.2022, "On licensing NRG POWER company, in electricity supply activity" by repealing various conditions set previously as result of completing the required documentation/information.

Procedures initiated during July

During July, Energy Regulatory Authority (ERE) initiated the procedures for licensing the companies as follows:

- "POWER ENERGY" company in electricity trading and production activity from the photovoltaic plant, with production capacity 25 MW, located in Povelçë, Dërmenas Administrative Unit, Fier Municipality.
- "KËLCYRA 2020" company in electricity production activity from "Klisyrë" HPP, with production capacity 2 MW, located in Klisyrë, Tropojë.
- "GLOBAL TECHNICAL MECHANICS" company, in electricity production activity from generation photovoltaic plant with production capacity 12MW and auxiliary works, located in Kukes Airport area, Shtigen Administrative Unit, Kukës Municipality, for 25-year period.

According to the "Regulation on the procedures and terms for license issue, modification, transferring, renewal, recognition and license removal in power sector" as amended, ERE regarding all these applications continued the publication in the written media, on www.ere.gov.al website and social media platforms Facebook and LinkedIn to receive objections prior to the respective licensing decision.

Other decisions

There is approved the administrative measure to remove the license of debtor companies "ENERGIA GAS AND POWER ALBANIA" company in electricity supply activity as well as "ENERGY SUPPLY-AL" company in electricity supply and trading activities.

There are reviewed the respective licensing decisions for production activities of "NOVA SOLAR SYSTEM" company, and partially from "H.K HEC GRABOVA 2" company following the verification of compliance of the conditions from "NOVA SOLAR SYSTEM "company, and partially from "H.K HEC GRABOVA 2" company.

It is approved the amendment of point 2 of ERE Board Decision no. 94, dated 28.04.2025 "On licensing
"SOLAR HORIZON" company in electricity production activity, from the photovoltaic plant, with production
capacity 2 MW", setting the date 05.11.2025 as the final term to initiate the exercise of electricity production
activity.

ERE Board Decision no. 51, dated 03.03.2025, "On licensing "DELIU 3D" company in electricity production activity from "Shiroku" HPP, with installed capacity 1,6 MW" setting date 31.01.2026 as the term within which this company shall initiate the exercise of electricity production activity from "Shiroku" HPP.

Additionally reviewed:

- ERE Board Decision no. 107, dated 23.05.2025, "On granting the authorization by ERE to set the quota's of "DELIU 3D" company as a means to guarantee the obligation to third parties" by revoking one of the predefined conditions after the verification for completion of the required documentation according to point 3 of this decision.
- ERE Board Decision no. 191, dated 06.06.2023, and Decision no.147, dated 24.04.2023, "On the request of "SPV BLUE 1" company, to obtain the authorization by ERE for the transfer of immovable assets (through the establishment of the security interest) of the BLUE 1 photovoltaic plant in favor of Green for Growth Fund Southwest Europe S.A, SICAV-SIF" as well as the grant of the authorization by ERE for the set of the quotas of "SPV BLUE 1" company as a means (Security Interest) to guarantee the obligation to Green for Growth Fund Southwest Europe S.A, SICAV-SIF". On the meeting dated 31.7.2025 it is approved the grant of the authorization for establishing a new security interest on the fix assets and the quotas of the photovoltaic plant 'Blue 1', in favor of "Fibank Albania" company and the "First Investment Bank AD" (Bulgaria), within the framework of loan agreement, for refinancing purposes.

Other decisions:

It is accepted the request of "SunPro" company to suspend until on date 30.09.2025 of ERE Board Decision period for licensing in electricity production activity from the aeolian plant with production capacity 3 MW to complete the full and update the documentation that is missing, as well as the 30 day extension of the decision period for the request of "Energovia.Albania" company for licensing in electricity trading activity, a period during which the company shall deliver the missing documentation. It is also suspended with the request of the company itself ERE Board Decision for the request of "IDI 2005" company for licensing in electricity production activity from the photovoltaic plant, with production capacity 8.8 MW, located in Dërmenas Administrative Unit, Fier Municipality.

Decisions regarding tariffs and prices

On the meeting of date 8 July, ERE Board approved the electricity sale price supplied from the Supplier of Last Resort for June 2025 of about 13.97 ALL/kWh for the customers connected in 35 kV voltage level.

REMIT register

The Market Participants that are registered at the Transmission System Operator (TSO) company, to participate at the electricity market, are also registered on REMIT register, according to the "Regulation for the wholesale electricity market integrity and transparency (**REMIT**)", approved with ERE Board Decision no. 126, dated 17.05.2021. This register is published and updated on 31.07.2025 on ERE website https://ere.gov.al/en/energy-market/remit

Authorizations for financial guarantees

ERE Board approved the requests of some companies regarding the obtain of **authorization** for the pledge of quotas and the set or transfer of fixed assets (through mortgages and/or security agreements) as means to guarantee the compliance of obligations to third parties, to finance the construction of electricity production plants. Within this framework are granted the authorizations for the companies as follows:

- "ZENINA" company, licensed with ERE Board decision no. 25, Dated 27.01.2025 in electricity production activity from the photovoltaic plant with installed capacity 2 MW, for a 30-years period.
- "SLR ALBANIA" company, licensed with ERE Board Decision no. 262, dated 02.12.2024 in
 electricity production activity from the photovoltaic plant with installed capacity 2 MW,
 for a 25-years period.
- "NOVA SOLAR SYSTEM" company, licensed with ERE Board Decision no. 242, dated 03.08.2023, in electricity production activity from the photovoltaic plant with 50 MW capacity.
- "CONSTRUCTION ENERGY PARTS (C.E.P)" company, licensed with ERE Board Decision no. 306, dated 30.11.2022 in electricity production activity from the electricity photovoltaic generation plant with production capacity 2 MW, for a 25-years period.
- "DIMAX ALBANIA" company, licensed with ERE Board Decision no. 308, dated 30.11.2022 in electricity production activity from the electricity photovoltaic generation plant with production capacity 2 MW, for a 25-years period.
- "ARIS ALBANIA" company, licensed with ERE Board Decision no. 55, dated 22.02.2021 in electricity production activity through various HPP-s, with total installed capacity 4755 kW, for a 30-years period.
- "HYDROPOWER" company, licensed with ERE Board Decision no. 307, dated 30.11.2022
 in electricity production activity from the electricity photovoltaic generation plant with a
 production capacity 2 MW, for a 25-years period.

Also, are approved the requests of the companies as follows:

- 1. "ARIS ALBANIA" company regarding the change of the owner that controls the interests of the company.
- 2. **"HYDROPOWER"** company regarding the termination of the administrative procedure initiated with ERE Board Decision no. 101, dated 12.05.2025 on the "Initiation of the procedure to review the request of "HYDROPOWER" company to grant the authorization from ERE for its fix asset transfer (through the establishment of mortgage).

The handled issued include: The settlement of the disputes between the customers and the FSHU, DSO operators to clarify the issues regarding: üOver - invoicing - incorrect invoicing of electricity; üFictitious contract;

ülnvoicing as result of meter testing; üEconomic damage invoicing.

The clarifications with the licensed companies regarding their applications to obtain the authorization by ERE to impose security interest on the quota of the companies. Discussions with the interested parties, respectively "Zharrëza" company representatives, Mr. Lavdosh Ferruni (Organic Agriculture and Environment Association), representatives of "Fier Thermoelectric" company, the National Environment Agency, the Regional Directorate of Environment Fier, and TSO company, regarding the objections/comments submitted by the above-mentioned environmental associations on the application of "Fier Thermoelectric" company for licensing in electricity production activities. The parties were informed that ERE shall take the final decision on the company's application based on the applicable legislation, the submitted documentation, and the comments/objections received

There are also approved:

- · Various additions and amendments to the standard electricity sale-purchase contract between the electricity production association charged with public service obligation, whose shares are fully/partially controlled by the state, KESH company and the universal service supplier (FSHU) company, for the supply of the customers that
 - are supplied by FSHU company". These amendments result from the update of the legal and by-legal references to the contract, developments to electricity market liberalization and references on the acts that define the electricity sale price for the customers that are supplied by FSHU company including customers with a specific status.
- Joint document of three Energy Regulators, ERE, RAAEY and ARERA: "Approving an amendment on TAP Network Code", proposed by TAP AG on 12 May 2025.
- "GUIDELINES FOR TRANS ADRIATIK PIPELINE MARKET TEST FOR 2025", submitted by TAP AG.
- Request of TAP AG for not applying ISO/IEC 27001 standard, and the classification as a subject in the framework of implementing NIS2 Directive according to the Regulation for Cyber Security of Critical Infrastructure in Power Sector.
- "Proposal of TAP, SRG and DESFA project for Incrimental Capacity process for 2023 - Binding Phase", object of approval by the regulators of Italy and Greece, (ARERA and RAAEY).

Also on ERE website there are updated as follows:

- -The register of the requests and responses at the Transparency Program;

On 11.07.2025 on ERE website it is published for public consultation the document "For the establishment of a guideline on the operation of electricity transmission system " within the framework of transposing the legislation of Energy Community Secretariat, which comments are expected until on 04.09.2025.
